**INVITATION TO BID**

The Department of Education (DepEd), through the **FY 2016 General Appropriations Act**, intends to apply the sum of **Philippine Pesos Two Million, Eight Hundred Seventeen Thousand, and 00/100 (Php2,817,000.00)**, being the approved budget to eligible payments under the contract for the **Door to Door Supply and Delivery of School Furniture to Newly Constructed Classrooms – Batch 5 Under the CY 2016 Basic Educational Facilities Fund**, detailed as follows:

The DepEd, through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned goods and ancillary services. Bids received that exceed the ABC shall be rejected at bid opening. Late bids shall likewise be rejected. Bidder must bid for all the items, otherwise, the bid shall be rejected.

Prospective bidders may offer any type of materials of the armchairs, i.e. engineered bamboo (e-bamboo), bamboo and steel, all wood, wood and steel, or non-wood, for the project it will bid for.

Prospective bidders must have completed a single largest contract similar to the Project, completed within five (5) years immediately preceding the deadline of submission and receipt of bids, with an amount equivalent to at least 50% of the ABC of the contract to be bid.

Bidding is restricted to Filipino citizens/sole proprietorships; organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Open competitive bidding will be conducted using a non-discretionary "pass/fail" criterion, evaluation and post-qualification procedures as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

A complete set of Bidding Documents may be acquired by interested Bidders from the DepEd Division of Davao del Norte, Government Center, Brgy. Mankilam, Tagum City Davao del Norte, upon accomplishment of a bidder's information sheet and payment of a non-refundable fee for the Bidding Documents to the DepEd Cashier, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Philippine Pesos Five Thousand and 00/100 (Php5,000.00)**. Only bidders that purchased the Bidding Documents will be allowed to submit bids.


The pre-bid conference is open to all interested parties who have or have not bought the Bidding Documents.
